The details of organising and conducting an airshow vary widely based on the specifics of your site, your goals and ambitions, your vision, your resources and much much more. This manual is an important and valuable starting point, but it is no more than a starting point.

No publication can guarantee the success or safety of your show. Good management, sound fiscal practices, common sense, hard work, and careful and early planning are each important factors in the ultimate success of your event. Operate your show as a business and always plan for the unexpected. Remember that every event and every site is unique. Visit other shows and gather as much information and as many ideas as you can before embarking on staging your event. Talk to other members of the EAC and of the wider airshow community. Read all the material available from your Civil Aviation Authority (CAA) and your military authorities, and most of all keep abreast of general activities and trends in aviation and, in particular, the airshow industry.



The EAC prides itself on the aim of 'Promoting Excellence and Safety in Airshows', both in Europe and much further afield. In doing so we work with our partner agencies to learn from mistakes, promote best practice and develop new and exciting areas of the industry.


